The <u>Co-operative Development Foundation of Canada (CDF)</u>, in partnership with <u>Co-operatives and Mutuals Canada (CMC)</u> and the <u>Canadian Association for Studies in Co-operation (CASC)</u>, established a scholarship fund in memory of Ian MacPherson to commemorate his lifelong contributions to the study and promotion of co-operatives.

As a scholar, educator and co-operative activist, Dr. MacPherson personified the relationship between Canadian co-operative academics and co-op practitioners. He served as president of both the Canadian Co-operative Association (now Co-operatives and Mutuals Canada) and Credit Union Central of British Columbia (now part of Central 1 Credit Union), as well as on the boards of various consumer, financial and health care co-operatives. He wrote dozens of articles and books about co-operatives, including A Century of Co-operation, the commemorative book marking the 100th anniversary of Canada's organized co-operative movement in 2009.

The namesake legacy fund supports travel, lodging and registration costs, up to \$1,000 per year per researcher, to support participation as a speaker at an academic conference related to the cooperatives and mutuals sector.

The fund is primarily intended to support graduate and post-graduate students, but members of the research community who are involved with the Canadian Association for Studies in Co-operation can be considered.
